ANTI-MONEY LAUNDERING, ANTI-TERRORISM FINANCING AND PROCEEDS OF UNLAWFUL ACTIVITIES ACT 2001

ANTI-MONEY LAUNDERING, ANTI-TERRORISM FINANCING AND PROCEEDS OF UNLAWFUL ACTIVITIES (DECLARATION OF SPECIFIED ENTITIES AND REPORTING REQUIREMENTS) (AMENDMENT) ORDER 2023

IN exercise of the powers conferred by sections 66B and 66D of the Anti-Money Laundering, Anti-Terrorism Financing and Proceeds of Unlawful Activities Act 2001 [Act 613], the Minister makes the following order:

Citation

1. This order may be cited as the **Anti-Money Laundering, Anti-Terrorism Financing and Proceeds of Unlawful Activities (Declaration of Specified Entities and Reporting Requirements) (Amendment) Order 2023**.

Amendment of paragraph 3

2. The Anti-Money Laundering, Anti-Terrorism Financing and Proceeds of Unlawful Activities (Declaration of Specified Entities and Reporting Requirements) Order 2014 [P.U. (A) 93/2014], which is referred to as the “principal Order” in this Order, is amended in paragraph 3—

(a) in subparagraph (1)—

- (i) by substituting for the words “The reporting institution” the words “Any person or class of persons under the regulation or supervision of the relevant regulatory or supervisory authority”; and
- (ii) by substituting for the words “determine that the reporting institution is in possession or control of any of the property” the words “determine whether such person or class of persons is in possession or control of any property”; and

(b) in subparagraph (2)—

- (i) by substituting for the words “The reporting institution” the words “Any person or class of persons under the regulation or supervision of the relevant regulatory or supervisory authority”; and
- (ii) by substituting for the words “thereafter for every six months interval” the words “thereafter at such intervals as may be determined by the relevant regulatory or supervisory authority”.
